AFFIDAVIT FOR PROOF OF RESIDENCY GUIDELINES

Affidavits may be approved by the Superintendent or designee, which will assist in maintaining a balanced enrollment among the District's campuses. An official Affidavit application for such enrollment must be submitted annually. This application must be signed by the MISD resident.

The affidavit must be submitted to the student's campus of attendance. Please contact the campus if further information is needed.

All affidavits will be reviewed and may be accepted using the following criteria:

- Completion of MISD Affidavit for Proof of Residency, obtained at the campus.
- Affidavit signed.
